

Capacity building interventions of SHARP-Pakistan for Police Officials

SHARP-Pakistan is striving for friendly Human Rights Pakistan. Achieving this vision, its professional human rights experts having vast competencies in the above-mentioned topic, are putting their efforts every day to arise a sense for human rights rich society in its people. Law enforcing agencies, lawyers, law students, Prosecutors and Judiciary play a vital role in advance societies in ensuring human rights to common person. SHARP-Pakistan has been traditionally arranging capacity-building initiatives for law enforcing agencies lawyers, law students, Prosecutors, community elders/representatives and Judiciary for seventeen years in Pakistan. Sensitization played an integral role in acomplishing the desired goals of the programme and for this purpose SHARP-Pakistan maintained close coordination with the law enforcement agencies particularly the police and the FIA to ensure that the refugees are not illegally detained and harassed. It also organizes training sessions for this audience group to sensitize them on human rights and refugee rights under international law and the significance of the "Principal of Non-Refoulement" is highlighted for humane treatment of refugee at the hands of law enforcers. SHARP held coordination meetings and organized sensitization sessions with the relevant stakeholders and the government line departments to ensure the effective and humane treatment of refugee while taking into account the age, gender and diversity (AGD) context.

In 2016, seven police trainings have conducted for police officials in Rawalpindi, Lahore, Mianwali, Karachi, Peshawar, Haripur and Buner. Total 206 police officials were trained by SHARP-Pakistan in Rawalpindi, Lahore, Mianwali and Karachi. Out of 206, the gender breakdown is 195 are male and 11 are female trained police officials of rank of Moharar, Head Constables and Constables, ASI, SI, Inspectors SHOs, IOs and DSPs. Along with Human Rights and Refugee Rights, Foreigner's Act.1946 and other Government notifications were also given space in the agenda for sensitization trainings.



Mr. Yasir Ayaz Khan delivered his session in the Police training at police line Rawalpindi on 11th February, 2016 by introducing United Nation High Commissioner for Refugees (UNHCR) and its mandate in Pakistan. He stressed on Refugee laws need to be understand by police and told to trainees what are the rights of refugees and the obligations of refugees as well as the host countries. It was to them that the UNHCR's mandate is to provide protection to refugees and to find durable solutions for them. The

principle of non-Refoulement was explained in a very easy way that made the clear the concept of trainees on the topic.

Ms. Ghazala Mirza gave a presentation on the topic of "Refugee Rights, International protection and the Legal Status of Afghans in Pakistan". She elaborated the Mandate of UNHCR/SHARP, definition of Refugees and their rights, International Protection, 1951 Convention, 1967 Protocol, Role of UNHCR in protecting the refugees and Due process of law. She further told the audience that Mandate of UNHCR is to provide international protection to refugees and to seek durable solutions for refugees by assisting Governments to facilitate the voluntary repatriation of refugees or their integration within new national communities.





Mr. Muhammad Mudassar Javed, Project Director, SHARP-Pakistan completed his session on the topic of Human rights and his organization struggle for human rights friendly Pakistan at police Training College Chung Lahore.

Mr. Muhammad Younas Sahibzada, Head of UNHCR Karachi office, elaborated in details the refugee rights and status of Afghan refugees in Pakistan at Police Training in Karachi on 29th March, 2016. He told that in principle, the rights and physical security is assured to a recognized refugee in many countries however, in Pakistan, the situation is different because it is not signatory to refugee laws and have not made yet any National refugee laws. The refugees are being managed under the ad-hock administrative arrangements/agreements between Govt. of

He directed to the concerned Police Officials not to harass and registered cases under Foreigners against Afghan Refugees having valid PoR Card issued from NADRA, Pakistan. Mr. Sarfaraz went on to say that Police Officers must know their responsibilities while dealing with public at large. He stressed to perform their obligations honestly. At the

end, he thanked all the participants' and the SHARP management for the training workshop.



Chief Guest Mr. Khalid Saeed (DSP) graced the closing session of the workshop as Chief Guest. He diligently observed the entire workshop, appreciated, and congratulated the SHARParranging Pakistan for such wonderful awareness session for the Police officials. He shared his personal experience and briefed that such intellectual programs should be promoted for the progress of the entire society. He said that this is the responsibility of all stakeholders of the society to work together for the betterment and uplift of the vulnerable segments of the country. He said that no one is ready to stand up for his own rights or for rights of other people. Anyone who passes by a situation where someone else's



rights are being violated and that person is very well observing the entire scene, does not make an effort of raising voice or does not even make an effort of helping the other person. He further briefed that these workshops must be conducted not only to give awareness to the common person but also to inform officials about their basic rights.



Chief Guest Mr. Usman Ijaz Bajwa, SSP Operations, Counter Terrorism Department Karachi thanked the SHARP and UNHCR for conducting sensitization training for police official in Karachi on 29th March, 2016 with also highlighted the role and responsibilities of law enforcement agencies specially the police officials who owed big responsibility to make the society crime free and to play their positive role for maintaining the peace in this crucial time of Pakistan. He appreciated the hard work of police and was expecting that we all will continue to play our positive role in

eradicating the crimes from the society and making our country a peaceful place for all.

It was recommended by the police participated in these trainings that this kind of initiatives should be taken on more traditional basis which benefits both society as well as police department".
