Situation Undate: Diplomatic Dialogue Amid Deepening Refugee Crackdown: March 2025 marked an escalation in both the humanitarian crisis and diplomatic activity concerning Afghan nationals in Pakistan.

The Government's March 31st deadline for Afghan Citizen Card (ACC) holders and undocumented individuals to voluntarily leave the country has now passed. Fears are mounting over the likelihood of intensified enforcement and mass deportations in the post-Eid period.

Despite official assurances that registered Afghan refugees holding Proof of Registration (PoR) cards are permitted to stay until June 30, 2025, reports from multiple districts suggest that even PoR cardholders are facing harassment, wrongful detention, and forced relocation—particularly in Islamabad and Rawalpindi, where the government has ordered the relocation of PoR holders to other areas.

The enforcement actions—initially limited to Islamabad and Rawalpindi—have expanded into several districts in Punjab, Sindh Khyber Pakhtunkhwa provinces, including Gujrat, Jhelum, Chakwal, Rahim Yar Khan, Bahawalpur, and Mianwali. These crackdowns have resulted in widespread arrests, detentions in holding centers, and deportations, severely affecting vulnerable individuals including women, children, and elderly Afghans.

As of March 2025, over 3.1 million Afghans reside in Pakistan, including around 1.35 million registered refugees and approximately 600,000 new arrivals post-2021, along with an unregistered population. Since 2023, more than 800,000 individuals have been repatriated to Afghanistan.

In a significant diplomatic development, Pakistan's Special Envoy for Afghanistan, Ambassador Muhammad Sadiq, met Afghanistan's Acting Foreign Minister, Mawlawi Amir Khan Muttaqi, in Kabul. The two sides reaffirmed their commitment to dialogue and cooperation on critical issues, including refugee management, trade and transit.

The Afghan Foreign Minister urged that Afghan refugees should be allowed to return gradually and with dignity, rather than face mass expulsions. Ambassador Sadiq reiterated Pakistan's intention to avoid politicizing humanitarian matters and promised practical steps, including facilitating visas and travel arrangements. Both sides also expressed commitment to continued highlevel engagements to resolve outstanding issues.

SHARP RESDONSE: High Alert & Coordinated Protection Efforts in a Complex and Evolving Environment: Amid - fears of a post-deadline crackdown and despite Ramzan the Eid holidays, SHARP-Pakistan remains fully mobilized. Our legal and protection teams continue to respond swiftly to the growing needs of Persons of Concern (PoCs) across various regions.

#### **Emergency Legal & Field Interventions**

Rapid Response: All SHARP field units operated on high alert, anticipating a surge in arrests and detentions after the March 31st deadline.

Helpline Activation: SHARP's emergency helplines remained active throughout the month to ensure PoCs could reach out for urgent support.

Holding Center Access: Protection teams conducted monitoring visits to holding centers, securing the release of several PoR cardholders detained mistakenly.

On-Site Legal Aid: Lawyers have been deployed at key detention points to advocate for due process, ensure humane treatment, and intervene in cases of arbitrary detention.

### **Proactive Advocacy & Coordination**

Engagement with Authorities: SHARP continues to coordinate with district administrations, police, and the Commissionerate for Afghan Refugees (CAR) to ensure procedural fairness and facilitate the resolution of high-risk cases.

High-Risk Profiling: A comprehensive list of vulnerable individuals—including unaccompanied minors, single-headed households, and PoCs with protection letters—is being updated for advocacy with local and international stakeholders.

Daily Situation Updates: Consolidated updates are being shared daily with UNHCR and IOM –UN to inform broader advocacy and protection planning efforts. Protection teams are conducting outreach to reassure refugee communities, combat misinformation, and build trust.

Unified Humanitarian Call SHARP urges humanitarian actors, UN agencies, and civil society partners to scale up protectionsensitive interventions. With post-deadline enforcement likely to intensify, particularly once the temporary Torkham border reopening agreement expires on April 15, coordinated advocacy and resource mobilization are essential.

SHARP reaffirms its unwavering commitment to protecting the rights, safety and dignity of Afghan refugees in Pakistan—and remains on standby for immediate response throughout this critical period.

### Swiss Ambassador Visits SHARP to Strengthen Refugee **Protection Efforts**

His Excellency Mr. Georg Steiner, the Ambassador of Switzerland in Pakistan, along with Ms. Laura Antonelia Salvato, First Secretary at the Swiss Embassy, was warmly welcomed by SHARP Chairman, Mr. Liagat Banori, and CEO, Mr. Mudassar Javed.

The delegation toured the Reception Desk Center (RDC), where Mr. Mudassar Javed provided insights into the refugee registration process. Mr. Liaqat Banori expressed





gratitude for Switzerland's continued support, sharing SHARP's achievements and the challenges faced by displaced communities. He emphasized the urgent need for a structured, dignified repatriation mechanism that prioritizes humanitarian concerns.

Ambassador Steiner commended SHARP's unwavering commitment to refugee protection and acknowledged the increasing challenges due to geopolitical shifts and funding constraints affecting humanitarian aid. He reaffirmed Switzerland's commitment to humanitarian principles and showed interest in strengthening refugee protection

frameworks and exploring sustainable solutions for displaced populations in Pakistan. The discussions also explored potential collaborations to enhance legal assistance, psychosocial support, vocational training, and livelihood opportunities for refugees, reinforcing a shared vision of protection, dignity, and empowerment.

### **UNHCR Delegation Visits SHARP Peshawar to Enhance Refugee Support and Coordination**

SHARP's Peshawar Regional Office had the privilege of hosting a distinguished UNHCR delegation led by Ms. Kiran Kaur, Assistant Representative (Protection), and Mr. Richard Grindell, Senior Protection Officer. The visit marked a significant opportunity to strengthen coordination and reinforce collective efforts in addressing the challenges faced by refugees in Pakistan.





PD (K-P) Ms. Memoona Batool Khan and Legal Manager Mr. Manzoor Ali welcomed the delegation and provided an in-depth briefing on SHARP's ongoing protection initiatives, legal aid services, and the pivotal role of the Reception Desk Centre (RDC) in assisting persons of concern. In a strategic discussion, both teams explored ways to enhance response mechanisms, address emerging protection challenges, and further streamline collaboration to ensure accessible and effective support for refugees. The delegation also acknowledged SHARP's commitment and frontline efforts in delivering legal assistance and community outreach.







### **UNHCR Security Officer Reviews SHARP's Safety Measures & Humanitarian Efforts**

Mr. Aatif Afzal, Project Director (ICT), led a tour of the Reception Desk Center (RDC), highlighting key security protocols and operational procedures ensuring both staff safety and efficient service delivery to vulnerable communities.
