Situation Update:

As of May 2025, the situation of Afghan refugees and other vulnerable foreign nationals in Pakistan remained complex and sensitive, amidst the evolving implementation of the Government's Illegal Foreigners Repatriation Plan (IFRP). While the initial waves of large-scale enforcement activities have somewhat subsided in last month or so, protection concerns persist — particularly for Afghan Citizen Card (ACC) holders, undocumented individuals, and mixed-status families who continue to face legal uncertainty.

Field reports from key refugee-hosting areas in Khyber Pakhtunkhwa, Punjab and Sindh, indicated a steady but reduced pace of forced and voluntary returns. Many returns remained motivated by factors such as deepening economic hardship, loss of livelihoods, rising housing insecurity, increasing societal pressure, and ongoing fears of renewed enforcement actions. Some individuals also expressed anxiety over ambiguous messaging regarding possible future phases of the IFRP, contributing to heightened psychological distress within affected communities.

Despite periodic official reassurances of a measured and phased approach, incidents of harassment, arbitrary arrests, evictions, and short-term detentions continued to be reported—particularly in urban centers such as Karachi, Peshawar, Lahore, and Quetta. Vulnerable groups — including women, children, the elderly, single-headed households, individuals with medical needs, and those lacking valid documentation — remain disproportionately affected.

Field coordination with local district authorities showed gradual improvement in certain areas, with some district administrations renewing their commitment to upholding the rights of registered refugees and ensuring that any repatriation processes remain voluntary, safe, and dignified in line with Pakistan's humanitarian traditions and international obligations. Community-based outreach and legal awareness sessions continued to be delivered across high-risk zones, providing accurate information on rights, available services, repatriation processes, and grievance redress mechanisms to empower refugee families in making informed decisions.

As the IFRP continues to evolve, sustained humanitarian coordination, evidence-based advocacy, field monitoring, and policy dialogue remain essential to ensure that protection-sensitive, non-discriminatory approaches are upheld and that no vulnerable individual is left behind.

Throughout May 2025, SHARP maintained an active and adaptive protection response to address the ongoing and emerging challenges faced by Afghan refugees, asylum-seekers, and other vulnerable populations affected by the IFRP enforcement.

In view of continued risks faced by ACC holders, undocumented individuals, and mixed-status households, SHARP further intensified its legal interventions, operating in close coordination with UNHCR, IOM, government counterparts, and civil society partners. Legal teams provided individualized legal counseling, case management, court representation, and documentation support, ensuring respect for due process and access to legal remedies, especially in cases involving detention, eviction, and threatened family separation.

Through sustained coordination with humanitarian partners and local authorities, SHARP contributed to improved referral pathways, strengthened protection responses, and the promotion of rights-based approaches in areas most impacted by enforcement activities. SHARP remains committed to its core mandate of protecting the rights, dignity, and well-being of all vulnerable populations, and continues to advocate for principled, humane, and protection-sensitive implementation of repatriation and return processes.

Mr. Mudassar Javed provided a comprehensive overview of SHARP's mission and operations, followed by a guided






Legal Aid and Protection Services (LAPS) Project
